UPON HEARING Counsel for the Claimant Ms. Maya Kellman, State Counsel (Ag.), Attorney-at-Law for the Claimant;

AND UPON READING the Claim Form filed on the 27th day of March 2026 and the supporting affidavit of Ms. Maya Kellman, State Counsel (Ag.) in the Office of the Director of Public Prosecutions, sworn and filed on the 31st day of March 2026 together with the Exhibits attached thereto;


AND UPON DETERMINING that this matter be deemed fit for an urgent hearing;

IT IS HEREBY ORDERED that;

1. Pursuant to **section 8(1)(a)** and **section 10A(1)** of the Act the Defendants be declared as listed persons for the purposes of the Act;
2. A Counter Proliferation Order be made against the Defendants **QDi.437: SAMI 2: JASIM 3: MUHAMMAD JAATA 4: AL-JABURI a.k.a.: a) Mustafa Adnan al-Aziz) b) Mustafa Adnan al-Azeez c) Sami al-Ajuz d) Hajji Hamid** and **QDi.438 ABD EL HAMID 2: SALIM 3: IBRAHIM BRUKAN 4: AL-KHATOUNI a.k.a a) Abu Omar Al Sarraf** pursuant to **section 10B** of the Act;
3. A Restraining Order pursuant to **sections 8(3)(a) and (4)** of the **Anti-Terrorism (Amendment) Act** and **section 54** of the **Proceeds and Instrumentalities of Crime Act** be made against the Defendants to freeze any:
 - i. property of the Defendants;
 - ii. property that is wholly or jointly owned or controlled, directly or indirectly, by the Defendants;
 - iii. property of any nature whatsoever whether movable or immovable that is derived or generated from other property owned or controlled, directly or indirectly, by the Defendants;
 - iv. property of a person acting on behalf of, or at the direction of, the Defendants,
 - v. pursuant to **section 8 (3) (b) of the Act** that the Defendants be prohibited from directly or indirectly possessing, controlling or having access to any property;

4. The Claimant serve a Certified Copy of the Order on the Financial Intelligence Unit (FIU) immediately;
5. The Court dispense with the requirement for service on the Defendants of the Declaratory Order and the Counter Proliferation Order
6. Pursuant to **section 10(1)** of the Act, the Claimant cause a copy of the Order, to be immediately published electronically and to be published in the Official Gazette and at least two (2) daily newspapers in circulation in Barbados, as soon as possible.
7. costs to be costs in the cause;
8. liberty to apply.
